The Superintendent recommends JBA Architects, P.C. as the most qualified firm to serve as the architect of record for current and future improvements (PI) projects, beginning with the bus garage and requests authority to negotiate an agreement with JBA Architects, P.C. for these services.

Rationale:

 The Ohio Revised Code outlines a qualifications-based selection process in ORC Sections153.65 through .71, which is required to be followed by public entities when professional design services are needed.

- 2. The Board as a need for an architect of record to provide design services as needed for current and future PI projects, beginning with the current bus garage project.
- 3. On behalf of the Board, the Superintendent, or his designee, issued a request for qualifications for professional design services and solicited qualifications from qualified firms for design services for current and future PI projects and to include in a qualifications file for use as needed if services will cost less than \$50,000.
- 4. One (1) qualification submittals were received and reviewed. Due to being less than three (3) qualification submittals, there is no requirement for any ranking of firms.
- 5. A proposal has been requested from JBA Architects, P.C. for services required for the bus garage project and an agreement has been prepared for these services.
- 6. The qualifications received from any/all firms will be placed in a qualifications file for use on projects requiring services of an architect, engineer, surveyor, or landscape architect for which compensation will not exceed \$50,000, as long as the qualifications are current (not older than 1 year).

The Board resolves as follows:

- 1. The Board selects JBA Architects, P.C. as the firm determined best qualified to serve as the architect of record for current and future PI projects, beginning with the bus garage project.
- 2. The Board authorizes the Superintendent, or his designee, to negotiate an agreement with JBA Architects, P.C. to serve as the Board's architect of record and to begin design services required for the bus garage project.
- 3. The Board approves the establishment of a qualifications file for design firm qualifications to be used for improvements for which design services will cost less than \$50,000.
